#### **PROJECT STAGES**

#### 1. Brand Identity Design (\$1,000)

Five initial logo concepts, developed into one main logo with the opportunity for you to make up to three rounds of revisions.

- + One main logo & two secondary logo marks
- + Sub mark system for business locations (Richmond, Berkeley)
- + Sub mark system for clubs (Barbell, Run/Endurance)
- + Brand colors (outlined in Brand Guidelines)
- + Font recommendations (outlined in Brand Guidelines)

#### 2. Brand Guidelines (\$150)

Once branding is complete, a brand guide PDF will be designed—outlining logo usage guidelines, colors, typography and style guide for Google Docs and post-its.

### CHANGES & REVISIONS

This contract is fixed-priced, however, sometimes things change throughout the scope of a project. I don't want to limit your ability to change your mind. If you want to change your mind or add new elements at a later date, that is no problem. Any additional fees will be confirmed in writing prior to doing the work.

#### COPYRIGHTS

The original creator owns the copyright, however, once final payment has been cleared, the logo design copyright will transfer to you. A Transfer of Copyright form will be sent to you when the project is completed, and not likely to be subject to any last minute changes. You are responsible for having your new logo trademarked, if you choose to at this time.

#### **PAYMENT**

The first stage of this project costs \$1,150 (for the Brand Identity Design + Brand Guidelines). Half of the fee (\$575) is due before any work begins, with the remaining 50% (\$575) due before release of the digital files. Once stage 1 is complete, the remaining templates and brand assets will be created and charged by the hour after the project is complete.

To pay the 50% deposit, you have two options—
